### Points of Information (R. Lucci)

- H.S. teams who have WEVA members on them performed well in state competition
  - o St. Mary's of Lancaster won State Championship - 100% WEVA members on Varsity roster
  - o McQuaid Boys won Class A
  - o Eden Girls Class C – won States
  - o Penfield HS
- Will see more presence of non-working officials at tournaments (doing ratings)

### WEVA Board Conflict of Interest Documentation (J. Hughes)

- Rational behind this – WEVA reached over \$200K income going in & out. Accountant suggested such a form be signed by the BOD; the State Charities Bureau wanted transparency
- We are working on a **WEVA** policy, in the meantime, we are aligning ourselves with USA's Conflict of Interest policy.

### Registrar's Report (J. Hughes)

- Registration process started earlier this year (September 2011) Total = 2,015
- 28 Girls Clubs; 5 are new
- 11 Boys Clubs; 5 are new

  - o Teams must participate in two region events to compete at Regionals
  - o Discussion about a girl playing on a boys 14's team ... Motion: Allow a 14 yr-old girl player to play on a 14 yr-old boys team ... 1<sup>st</sup> T. Weislo/2<sup>nd</sup> R. Majeski/Defeated (0/7/0)

The Board has decided to allow this player to practice with a boy's club team as a registered WEVA member

- Discussion with THS representative regarding reserving rooms for Nationals; John will seek additional information
- Insurance Update – misconception. Within 48 hours of an injury, notify J. Hughes. WEVA insurance is more liberal than we once thought

- Suggestion to update "Commissions Corner". Adult pages also need updating. Once Junior's pages is rearranged, we will move onto Adult

#### Junior Business (T. Weislo)

- High Performance (T. Weislo)
  - All the documents have been created and ready to be posted on the Web
  - Need a 3<sup>rd</sup> try-out date and a Rochester location. 1<sup>st</sup> try-out scheduled is 3/11/12. 2<sup>nd</sup> is 03/25/12 at BNCC. 3<sup>rd</sup> one ... outstanding. Age divisions TBA.
  - WEVA HP camp July 19-21, 2012. HP is in Des Moines, IA. July 23 Opening Ceremony, July 24 – July 28 Competition
  - Hoping for a collegiate coach for boys (1) and girls (1) teams. Must convince Coach's of the value (huge recruiting hot bed). What will we pay them?
- "Rule of Two" rationale for girls bid tournament (R. Lucci)
  - At a recent NFVB Board Meeting, this issue came up questioning WHY this is required. Rocco defended it; and our Board agreed this rule will remain. The teams should support their own region, to maintain morale & competition in the region. The region is who ultimately pays bid \$ for Nationals.

#### Officials Report (J. Newland/F. Chase)

- Scorekeeper/Second referee Clinic updates

- New Libero rule perceptions – can't see the advantage for Juniors. Rule is vague, and interpreted differently in different regions.
- John and Fred attended National Clinic/PAVO Convention in San Antonio, TX. Looking for more consistency around the country. Also discussion about calling the 3<sup>rd</sup> contact/hand sets/push
- NFVB has at least ONE Canadian team registered for each tournament. Rocco suggests creating a document comparing USA vs. Canadian rules.
- Action item to be created for the referees to make a document to be posted online so the Canadian teams are informed about rule changes prior to tournament play. Mike Paul was suggested as an excellent resource. Let's not make a document from scratch, work off an existing comparison doc.

#### New Business

- Executive Director Review (S. Seabridge, J. Hughes)
  - o Growth in membership (10 new clubs) & in finances (operating expenses in savings). Providing clubs/teams the support they need.
  - o Impact Clinics have been successful. High Performance looks promising.
  - o Going after contracts with companies like Spaulding & Mizuno.
- Executive Director Search Procedure
  - o Will get input from the BOD and start committee for succession plan.
  - o Must establish timeline. John believes transition time will be 4–6 months, others believe one year is required for appropriate planning.
- Rochester will be hosting the National Collegiate Beach Volleyball Association Regional Qualifier–June 23, 2012. Winning team to fly out to CA for national tournament in August. Stipulation – two players must play at the same College. WEVA should inform club directors to notify old players.
- Next Meeting Proposed – March 12, 2012 at 6:00 p.m.
