### Registrars Report (J. Hughes)

- New clubs and merges may result in potential growth for the Region.
  - New Girls Club out of Rush-Henrietta HS called *Team Impact*, has coaches & facilities, and will likely field 3-4 teams total.
  - New Boys Club out of Athol Springs called *Red Raiders VBC* – will field 2 teams.
  - New Club named *Octane* (old Cobra Club).
  - Extreme & Premiere are merging, effective this Fall 2012.
- Adults 516 + Juniors 1920 = 2436. This number is within 5 of last year's number; dead flat. Final numbers for the year.

### Financial Report (J. Hughes)

- Motion: Approve 2011-2012 Budget, 1<sup>st</sup> R. Lucci/2<sup>nd</sup> R. Majeski/Passed (6/0/0). Last year's net profits were substantial, indicating an outstanding year. Why? No High Performance, no CAP Clinic, not all budgeted funds were spent on web maintenance or facilities.
- The new 2012-2013 budget was reviewed and voted on via email.

Director?
