USA Volleyball's High Performance Department has announced that it has opened and enabled registration for its 2011 boys' tryouts. USA Volleyball has scheduled 14 tryouts in 2011, including two opportunities in Hawaii, beginning on Jan. 7 and ending on March 12.
